

This matter came for consideration on the application of Larry Deiter, Director of Insurance for South Dakota, acting as Liquidator of ReliaMax Surety Company pursuant to SDCL Ch. 58-29B ("the Liquidator"), for an Order approving the Liquidator's Seventh Claims Report and recommendation to allow payment of distributions for uncontested claims by the Liquidator as contained in his Application No. 28 For Order Approving Liquidator's Seventh Claims Report and Recommendation (hereinafter "Application No. 28"). This application was made pursuant to SDCL 58-29B-125 for this Court's approval of the distributions paid to claimants within the Liquidator's Seventh Claims Report, pursuant to SDCL 58-9B-126. 3. That if any additional factors hereafter come to the attention of the Liquidator or his Special Deputy that may require modification, the Liquidator shall file an application to modify these claims.
